Mayor Long opened the meeting to the public for comments, there being none, he closed the meeting to the public.

ITEMS FOR DISCUSSION AND POSSIBLE OFFICAL ACTION:

On motion of Committeeman DiCroce, seconded by Committeeman Mozitis, it was moved to approve the minutes of the April 28, 2015 regular meeting. A roll call vote showed all members present voting yes, except Committeeman Gimbel who abstained.

On motion of Committeeman DiCroce, seconded by Committeeman Gimbel, it was moved to approve a request to have the State do a 2015 Gypsy Moth Survey. A roll call vote showed all members present voting yes.

RESOLUTIONS:

Resolution 2015R-39 authorizing approval of Change Order No.1 for Wallingford Way Repaving Project was discussed and the Committee had some questions so it was tabled until next meeting.

Resolution 2015R-40 the 2015 Amended Municipal Budget had a public hearing with no comments and on motion of Committeeman DiCroce, seconded by Committeeman

Gimbel, it was approved after the public hearing. A roll call vote showed all members present voting yes.

On motion of Committeeman Gimbel, seconded by Committeeman DiCroce, the 2015 Budget was adopted. A roll call vote showed all members present voting yes.

On motion of Committeeman DiCroce, seconded by Committeeman Gimbel, Resolution 2015R-41 cancellation of taxes on block 34 lot 22.08 totaling \$1,397.52 and block 34 lot 21 totaling \$578.33 was approved. A roll call vote showed all members present voting yes.

After much discussion, Resolution 2015R-42 Authorizing contract for affordable housing planner services to Leah Furey Bruder P.P., Bach Associates was tabled.

On motion of Committeeman DiCroce, seconded by Committeeman Gimbel, it was moved to approve the introduction of Ordinance 2015-5 an ordinance of the Township of Shamong fixing annual salary ranges of the members of the Township Committee and certain designated officers of said Township after first reading.
