The meeting was called to order by the Shamong Township Clerk, Mrs. Onorato, at approximately 7:01 P.M.

The Clerk stated that in accordance with the Open Public Meetings Law, notice of this meeting had been published in The Burlington County Times, and notification had also been sent to the Central Record and was posted accordingly.

Resolution 2013-2 on a motion by Mr. Wise, seconded by Mr. Burgin, Dante Guzzi Engineering was selected to serve as Engineer to the Joint Land Use Board. All members present were in favor.

Resolution 2013-3 On a motion by Mrs. Onorato, seconded by Mr. Wise, to authorize using those depositories that are legally approved by the State of NJ. All members present were in favor.

On a motion by Mr. Sweet, seconded by Mr. Burgin it was moved that the Joint Land Use Board meetings would be held the third Tuesday of the month at 7:00 pm in the Municipal Building. All members present were in favor.

On a motion by Mrs. Onorato, seconded by Mr. Bouffard it was moved that the Central Record would be the Official Newspaper of the Joint Land Use Board for 2013. The Burlington County Times was named as secondary newspaper. Applicants may use any newspaper having general circulation within Burlington County. All members present were in favor.
