On a motion by Mr. Vinceguerra, seconded by Mr. Sweet, Mrs. Onorato was selected to serve as Secretary for a one year term. All members present were in favor.

On a motion by Mr. Sweet, seconded by Mr. Long it was moved that the Joint Land Use Board meetings would be held the third Tuesday of the month at 7:00 pm in the Municipal Building. All members present were in favor.

On a motion by Mr. Wise, seconded by Mr. Burgin it was moved that the Joint Land Use Board escrow funds would be deposited in any bank doing business in New Jersey where the Township CFO has obtained a Certificate of Governmental Deposit Coverage. All members present were in favor.
